Groat Rural Ministry Accessibility Grant funds are managed under the direction of the WI Annual Conference Board of Trustees. Applications will be reviewed by the Board of Trustees in January, April, July and October and applicants notified via US mail within 2 weeks following grant review.

Support for accessibility improvements in facilities in Wisconsin's rural communities.

Grant Funds Info

- Matching funds available through a bequest from the Groat family.
- Funds available to support capital/physical building improvements that address accessibility in rural ministries/facilities.
- Grants to match up to 50% of the total improvement expense.
- Grants available with a per facility/ministry lifetime maximum of \$10,000.
- Funds available until the Groat bequest is exhausted.
- Applications accepted throughout the year and reviewed/awarded in January, April, July & October.

Who Can Apply

Any United Methodist facility/ministry that

- Is located in Wisconsin
- Can self-identify as operating in a rural area/community.
- Is undertaking a capital/physical building improvement that addresses accessibility.
- Has a completed Annual Accessibility Audit for United Methodist Churches.

How To Apply

Submit a written request on church/ministry letterhead with the following:

1. Describe the church/ministry and how it meets the criteria of “rural”. Include how long the facility/ministry been in existence, and a description of it’s physical location.
2. What are the church/ministry plans to improve accessibility? Attach the completed accessibility audit form (see middle section of this brochure)
3. What are the verified costs of proposed modifications (ie, contractors bids, list of supplies with vendor costs, etc.)
4. What is the amount of grant funds requested? (cannot exceed \$10,000 lifetime per facility, or 50% of project costs as described above)
5. Other information to help the committee reach a decision.
